ORDER:

In the Government Order first read above, the Government have issued administrative approval for the implementation of Pradhan Mantri Fasal Bima Yojana (PMFBY) in all districts of Tamil Nadu (except Chennai) from Kharif, 2016 onwards.

2. In the Government Order second read above, orders were issued for notification of Crops, Districts, Firkas and Revenue Villages for Agricultural crops and Horticultural crops for notification of insurance units and publication in the Gazette under the scheme of Pradhan Mantri Fasal Bima Yojana (PMFBY) during Kharif, 2016 season.

3. In his letter fourth read above, the Director of Agriculture has sent the notification proposal for implementation of Pradhan Mantri Fasal Bima Yojana during Kharif, 2017 for approval and issue of Government Orders and notification. In his proposal he has stated that 38th State Level Coordination Committee on Crop Insurance meeting was held on 30.03.2017 for implementation of Pradhan Mantri Fasal Bima Yojana (PMFBY) in Tamil Nadu during Kharif 2017 and during the meeting it was decided to notify the crops and areas which were notified during Kharif 2016. The 31 districts of Tamil Nadu (except Chennai) are formed into three clusters by combination of 3 high risk districts, 2 medium risk districts and 5-6 low risk districts as follows:-

Indemnity Level for the purpose of calculation of Threshold yield is fixed at 90% for low risk districts, 80% for medium risk districts and 70% for high risk districts. The following insurance companies were selected as implementing agency for the three clusters:-

He has also furnished the details of scheme, localized perils notified in the district, premium rate approved for the crops notified in all the districts in Kharif, 2017.

4. The Director of Agriculture has also stated that the units notified in Kharif, 2016 (district wise, crop wise details) will continue to be notified in Kharif, 2017 as per G.O.(Ms).No.270, Agriculture (AP6) Department, dated 23.8.2016. The discrepancies noted if any in hierarchy during implementation / uploading in Government of India's portal / while compensation could be reconciled with Department of Economics and Statistics and that may be adopted as final.

5. The Director of Agriculture has, therefore, requested the Government to issue orders for notification of implementation of Pradhan Mantri Fasal Bima Yojana (PMFBY) in Kharif, 2017 season, notification of implementation agency (Insurance Company) for implementation of the scheme in the three clusters and the Premium Rates approved for Kharif, 2017 season and also requested to issue Notification of insurance units notified during 2016, continue to be notified in 2017 too for enrolment of farmers under Pradhan Mantri Fasal Bima Yojana (PMFBY).

5. The Government, after careful examination of the proposal of the Director of Agriculture accept the same and accordingly hereby notify the Crops, Districts, Firkas, Revenue Villages, insurance units and approved premium rates for Agricultural Crops and Horticultural Crops for the effective implementation of the Pradhan Mantri Fasal Bima Yojana during Kharif, 2017 season as shown in the Annexures I, II and III to this order.

7. The claims under the Pradhan Mantri Fasal Bima Yojana Scheme shall be settled on the basis of yield data furnished by the Director, Department of Economics and Statistics as per prescribed cut-off dates for the notified crops / districts / firkas / revenue villages for the effective implementation of Pradhan Mantri Fasal Bima Yojana scheme for Kharif, 2017 season and not on the basis of the Annavari Certificate / Gazette notification declaring the area as Drought / Flood / Cyclone affected etc., by the District Collectors

NOTIFICATION FOR K-HARIF 2017

ANNEXURE I

Pradhan Mantri Fasal Bima Yojana (PMFBY) will be implemented in all districts of Tamil Nadu (except Chennai) with the State Government subsidy during Kharif 2017 season.

I. Objectives of Pradhan Mantri Fasal Bima Yojana (PMFBY):

Pradhan Mantri Fasal Bima Yojana (PMFBY) aims at supporting sustainable production in agriculture by way of

- a) Providing financial support to farmers suffering crop loss/damage arising out of unforeseen events.
- b) Stabilizing the income of farmers to ensure their continuance in farming.
- c) Encouraging farmers to adopt innovative and modern Agriculture practices.
- d) Ensuring flow of credit to the agriculture sector, which will, contribute to food security, crop diversification and enhancing growth and competitiveness of agriculture sector besides protecting farmers from production risks.

II. Coverage of farmers:

All farmers including share croppers and tenant farmers growing the notified crops in the notified areas are eligible for coverage.

- Compulsory to loanee farmers.
- Optional for non loanee farmers.

III. Coverage of risks and exclusions:

1. **Prevented Sowing/ Planting Risk** - Insured area is prevented from sowing/planting due to deficit rainfall or adverse seasonal conditions and due to non release of irrigation water on scheduled date of opening of dam for irrigation in its command areas
2. **Standing Crop (Sowing to Harvesting)** - Comprehensive risk insurance is provided to cover yield losses due to non-preventable risks viz. Drought, dry spells, flood, inundation, pests and diseases, landslides, natural fire and lightning, storm, hailstorm, cyclone, typhoon, tempest, hurricane and tornado.

3. **Post-Harvest Losses** - Coverage is available only up to a maximum period of two weeks from the harvesting for those crops which are allowed to dry in cut and spread condition in the field after harvesting against specific perils of cyclone, cyclonic rains and unseasonal rains.

38th State Level Coordination Committee on Crop Insurance approved to follow the same procedure adopted to the fix seasonality discipline as per the G.O.Ms.No.293 Agriculture (AP6) Department, dated 12.09.2016.

4. **Localized Calamities** - Loss/damage resulting from occurrence of identified localized risks of hailstorm, landslide and inundation affecting isolated farms in the notified area. (As approved by 38th State Level Coordination Committee on Crop Insurance (SLCCI)).

IV. Sum Insured:

Sum Insured for both Loanees and Non Loanees farmers will be the same and equal to the Scale of Finance as per Operational Guidelines and Tender agreement.

V. Premium Rates and Premium Subsidy:

Farmers Premium: Actuarial Premium Rate (APR) would be charged under Pradhan Mantri Fasal Bima Yojana (PMFBY) by the Implementing Agency (IA). The rate of Insurance Charges payable by the farmer will be as per the following table:

VI. Seasonality discipline:

As per Operational Guidelines, 38th State Level Coordination Committee on Crop Insurance meeting has been convened on 30.03.2017 and Seasonality / cut off dates for the crops notified under Pradhan Mantri Fasal Bima Yojana are given below:-

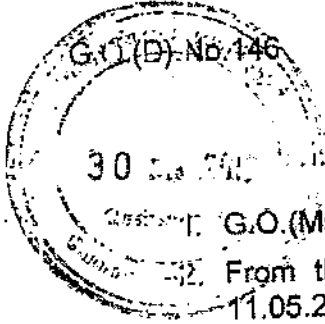

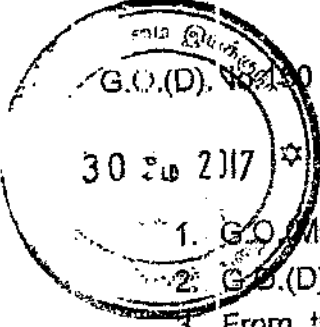
