In partial modification of Cooperation Department Resolution No.2926/Coop., dated 12.04.2016, the cut-off date for submission of insurance proposals is extended upto 10th August 2016 for Kharif 2016 under Pradhan Mantri Fasal Bima Yojana (PMFBY) in pursuance of Letter No.13017/01/2016-Credit-II, dated 03.08.2016 of Government of India, Ministry of Agriculture & Farmers Welfare, Department of Agriculture, Cooperation & Farmers Welfare, New Delhi. Accordingly, the seasonality discipline for different activities for Kharif 2016 under PMFBY indicated at para 9 in the aforementioned Resolution is revised as follows:-
